UNIT PARTICIPATION AND DONATIONS ARE ESSENTIAL TO THE IMPLEMENTATION AND SUCCESS OF THE HFGCP. PER THE REFERENCE, ELIGIBLE RECIPIENTS INCLUDE: SINGLE INCOME FAMILIES OF ACTIVE DUTY MARINES AND SAILORS (E-4 AND BELOW) AND DEPARTMENT OF DEFENSE (DOD) EMPLOYEES (GS-5/NF-2 AND BELOW) WITH AT LEAST ONE CHILD OR OTHER LEGAL DEPENDENT (E.G., PARENT) WHO CURRENTLY RESIDE IN OKINAWA WITH THE SERVICE MEMBER; OR DOD EMPLOYEE WHEN SPECIAL FINANCIAL NEED EXISTS; OR SINGLE INCOME FAMILIES OF ACTIVE DUTY MARINES AND SAILORS (E-5) WITH TWO OR MORE CHILDREN; OR LEGAL DEPENDENTS WHO CURRENTLY RESIDE IN OKINAWA WITH A SERVICE MEMBER WHEN SPECIAL FINANCIAL NEED EXISTS. PROVISION, MSC COORDINATORS SHOULD QUALIFY ANY FAMILY CURRENTLY RESIDING IN OKINAWA WHOSE SPONSOR IS DEPLOYED TO COMBAT OPERATIONS DURING THE DECEMBER HOLIDAY PERIOD AND FINANCIAL NEED EXISTS. ELIGIBLE

FAMILY MEMBERS MUST BE PHYSICALLY PRESENT IN OKINAWA DURING THE DECEMBER HOLIDAY PERIOD. FAMILIES VACATIONING OFF-ISLAND DURING THE DECEMBER HOLIDAY PERIOD DO NOT QUALIFY FOR THIS PROGRAM.

2. THE HFGCP, WHICH UTILIZES ONLY DECA GIFT CARDS, IS SUPPORTED SOLELY

BY DONATIONS FROM INDIVIDUALS, UNITS, AND PRIVATE ORGANIZATIONS. HISTORICALLY, THE AVERAGE MONETARY AMOUNT PROVIDED TO EACH ELIGIBLE FAMILY IS \$50. THIS AMOUNT MAY CHANGE IN VALUE AS NECESSARY TO ENSURE AS MANY ELIGIBLE FAMILIES AS POSSIBLE RECEIVE GIFT CARDS. DONATIONS CAN ONLY BE ACCEPTED IN THE FORM OF DECA GIFT CARDS (\$50 OR \$25 DENOMINATIONS). DONATIONS SHOULD BE SUBMITTED TO MARINE AND FAMILY PROGRAMS, BLDG 445, CAMP FOSTER BY 1 DECEMBER 2023. THE FOLLOWING INFORMATION IS PROVIDED FOR COMMANDERS AT EACH LEVEL TO HELP ENSURE A SUCCESSFUL PROGRAM.

A HFGCP KICKOFF MEETING IS SCHEDULED FOR 26 OCTOBER 2023 FROM 1530 TO 1600 INSIDE THE CAMP FOSTER MARINE AND FAMILY PROGRAMS, BUILDING 445, ROOM 201, FOR ALL UNIT REPRESENTATIVES. MEETING ATTENDANCE IS ENCOURAGED, BUT NOT REQUIRED FOR UNITS TO PARTICIPATE IN THE HFGCP.

THE UNIT HFGCP REPRESENTATIVE IS REQUIRED TO SUBMIT THEIR UNIT ROSTER OF ELIGIBLE FAMILIES NO LATER THAN 28 NOVEMBER 2023. THE UNIT ROSTER OF ELIGIBLE FAMILIES MUST BE SUBMITTED IN ACCORDANCE WITH THE REFERENCE, AS FRRORS

MAY RESULT IN A REDUCTION OR DUPLICATION OF GIFT CARDS DISTRIBUTED ISLAND-WIDE.
