

VEHICLE JUNKING MADE EASY!

No Fees & Free Towing!

HOW TO JUNK YOUR VEHICLE AT FOSTER TYPHOON MOTORS:

1) Go to the Joint Services Vehicle Registration Office (JSVRO) next to the Commissary on Camp Foster. Tell them you are junking your vehicle with Typhoon Motors. You will receive **2 Notarized Letters of Attorney** and **2 De-registration Worksheets**.

2a) If your vehicle drives (easiest, fastest, & most convenient), ensure the Government of Japan Inspection (GOJ)/Japanese Compulsory Insurance (JCI) and your Personal Damage Insurance (PDI) are valid. Ensure you have **both license plates, Road Tax sticker, and JCI sticker**. Drive it to Camp Foster Typhoon Motors.

2b) If your vehicle does not drive, you will need to remove and bring in **both license plates, Road Tax sticker, JCI sticker, and vehicle keys**. Once the de-registration process is complete, we will tow your vehicle for free. Please call us if you are having trouble getting these items.

3) From your title package you will need to bring: the **Japanese original title** (purple or tan document), **current year Road Tax receipt, DD Form 430 Base Registration Form** and **Recycle Fee Receipt**.

4) Identification: Military ID Card or SOFA license.

5) Bring the above to Camp Foster Typhoon Motors, 7 days a week, 0900-1730. The de-registration process takes about 20 minutes.

6) New Service: If you would like us to pick up you and your vehicle for junking, and you have all of the above documentation ready, call 645-1799 to set an appointment.

Other Circumstances:

- If junking a vehicle for someone else, you will need a valid Power of Attorney (POA) and an updated DD Form 430. When completing required documents, complete all information to include the DD Form 430, Letters of Attorney and De-registration Worksheets as if YOU were the owner of the vehicle for which you hold the POA.

- All liens / loans on the vehicle must be cleared prior to de-registering. Check your DD Form 430.

- Unpaid Road Tax can be paid at our office for white "Y" plate cars. Yellow "A" plate cars and motorcycles must pay Road Tax at the local City Office.

- If your Recycle Fee Receipt is missing, we will reprint it for you at no cost.

- If one or both license plates are missing, the registered owner will need to obtain a missing plates affidavit from PMO or the local police. POA holders are not authorized to request the affidavit.
