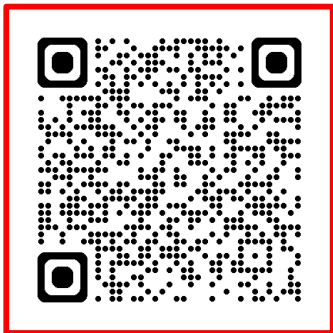
- Liberty cards are required for all personnel E-5 and below.**

GENERAL SAFETY CONSIDERATIONS

- **Heat/Humidity:** Heat is merciless. You must acclimatize, hydrate, and make smart nutrition habits.
- **Unit PT, PFTs, CFTs:** Ensure that you have what is required to address a heat illness every time (water, ice, safety vehicle, and training about what to do).
- **Make sure Others Can See You in the Dark:** Wear reflective clothing when exercising in hours of darkness.
- **Personal Protective Equipment (PPE):** Ensure that you and your children wear PPE when riding bicycles, skateboards, etc.; specially, helmets on and off-Base.
- **School Bus Stops:** We have consolidated bus stops. Please ensure that your children follow the walkways that have been put in place for their safety and not walking between busses or delineators.
- **Side Walks:** There aren't many sidewalks on base. When walking, please remain as close to the side of the road as possible and train your children to pay attention to traffic. Drivers, slow down and pay attention to pedestrians.
- **Construction Zones:** There are major construction projects at all camps at this time. Be mindful of construction zones and ensure your children also know to stay away from these areas and only transit through marked vehicular and pedestrian ways, which will always be present.





NEW JAPANESE LAW ABOUT SMALL MOTORIZED DEVICES (ELECTRIC BICYCLES, SCOOTERS, & KICKBOARDS)

- What are the characteristics of these devices:
 - Have a length of up to 190cm and a width of up to 60cm
 - Cannot accelerate over 20kph
 - Cannot change the top speed setting while driving
- New Japanese Traffic Law requirements:
 - Must be at least 16 years old to operate
 - Must wear helmet
 - Must be covered under compulsory automobile insurance
 - Must be registered and display number plates
 - Can only be driven on roadways and not on pedestrian walkways
 - Must remain to the left edge of the road
 - Must obey all traffic signal and rules of the road (hit and run, DUI, distracted driving rules apply)



Segways, Skateboards, and Hoverboards are not allowed on public roads



E-Bikes capable of speeds above 20kph fall under the same category as mopedS and require Japanese Compulsory Insurance, Liability Insurance and a drivers license.

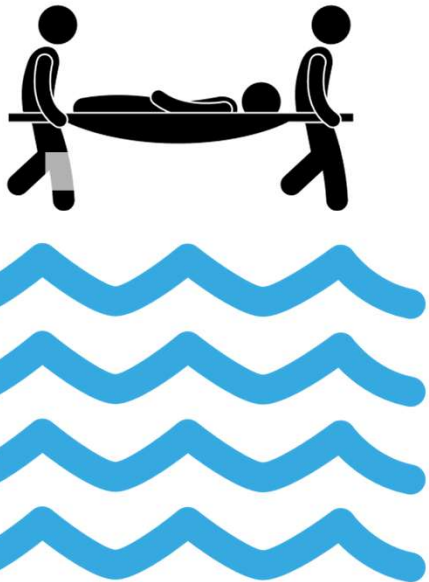
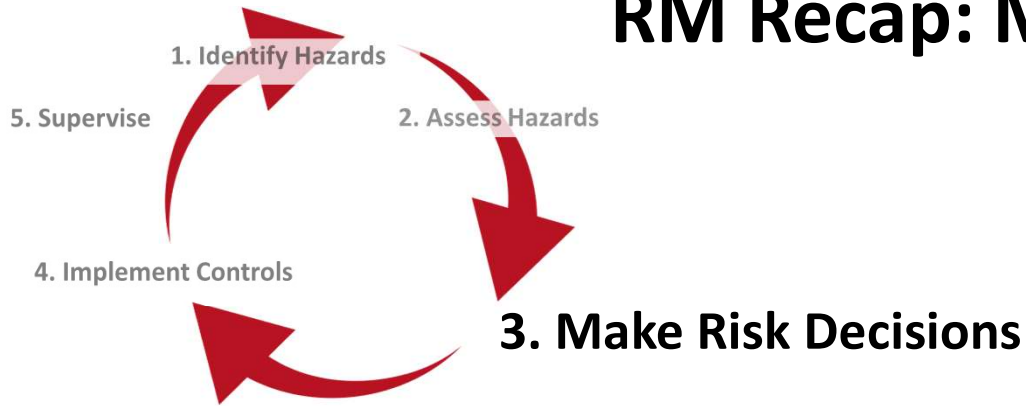

Understanding Your Presence



- **Regional Facts:**
 - Strategic location for power projection
 - 60% of world's population
 - 43 Countries
 - World's greatest concentration of Armed Forces (China, India, N Korea, S Korea, Russia, Vietnam)
 - 5 of 7 Major U.S. Defense Treaties
 - Strategic lines of communication and chokepoints
- **Potential Flashpoints:**
 - 60% of world's natural disasters
 - Regional state instability
 - Active extremist cells



Ryukyu Island Chain



Ryukyu Island Chain:

- Stretches 650 mi (1,050 km)
- 3 principle groups
 - Amami Islands
 - Okinawa Islands
 - Sakishima Islands
- 100+ islands

Okinawa is the largest, most populated island



CUI
History

- **1429 – Ryukyu Kingdom consolidated**
 - Tributary system with China
 - Center of commerce between Southeast Asia, China, Japan, and Korea
- **1609 – Satsuma clan invades Ryukyu**
- **1853 – U.S. Navy Commodore Perry visits Ryukyu**
- **1879 – Okinawa becomes Japan's prefecture**





History (continued)

- **Dec. 7, 1941 – Japan attacked U.S. Pearl Harbor**
 - Island-hopping Campaign in the Pacific caused heavy casualties
- **March 26 to June 23, 1945 – Battle of Okinawa**
 - Heavy military casualties
 - 1/4 of civilian population killed
- **Sept. 2, 1945 – Japan officially surrendered**
- **Sept. 8, 1951 – Peace treaty signed with Japan**
 - U.S. granted indefinite administrative control of Okinawa
- **April 1953 – U.S. Civil Administration began land expropriations for base construction**
- **May 15, 1972 – Reversion**
 - Full administrative control of Okinawa returned to Japan





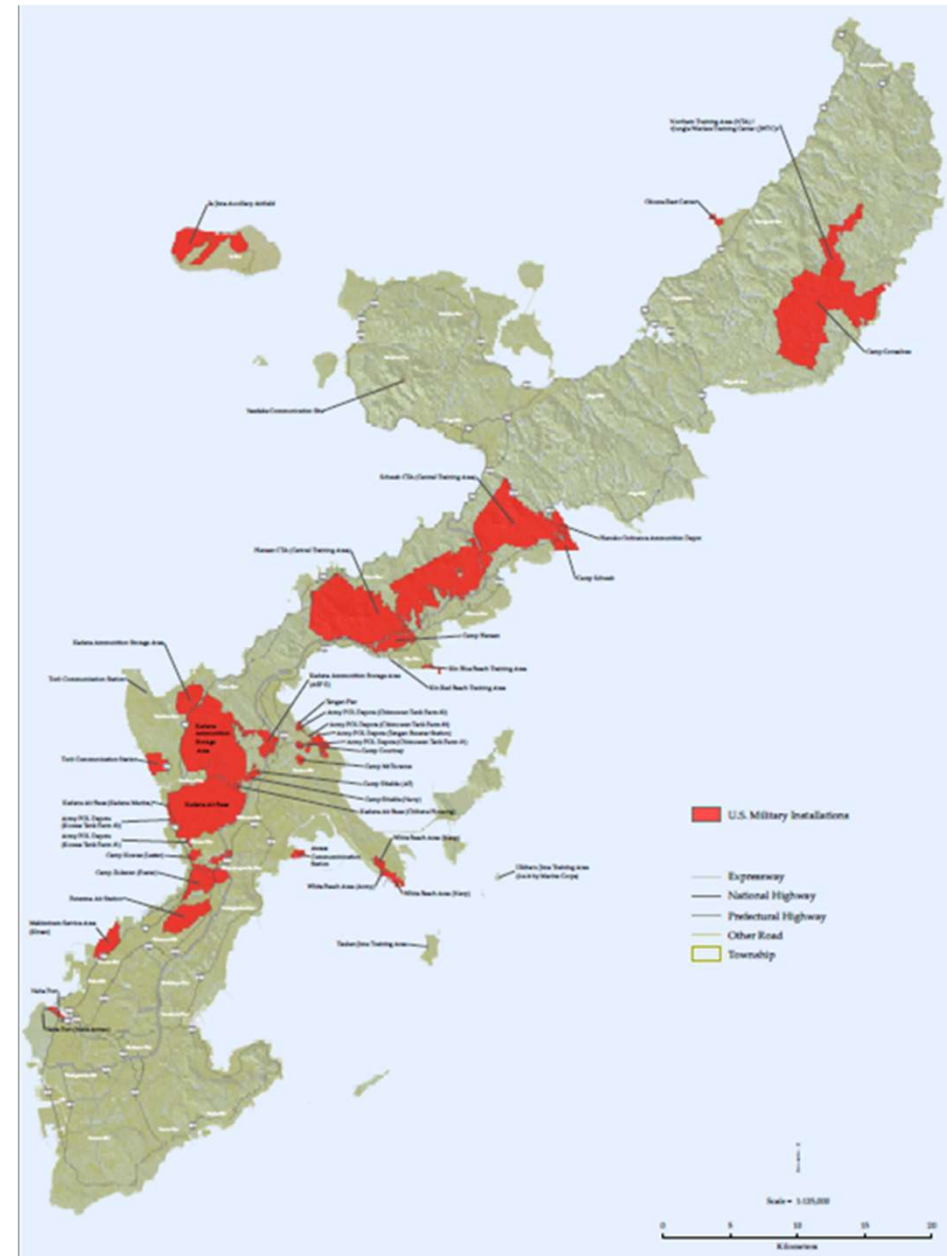
Challenges and Conduct

U.S. Military Challenges

- Large U.S. base presence
 - Utilize large amount of land area
 - Bases in densely populated areas
- Increase in domestic/ international tourism
- Environmental impacts and noise pollution
- Incidents and accidents

Military members held to a high standard of personal and professional conduct

- Action of one can have strategic consequences





Status of Forces Agreement

Article VI

“For the purpose of contributing to the security of Japan and the maintenance of international peace and security in the Far East, the United States is granted the use by its land, air, and naval forces of facilities and areas in Japan. The use of these facilities and areas” ... “shall be governed by a separate agreement ...”

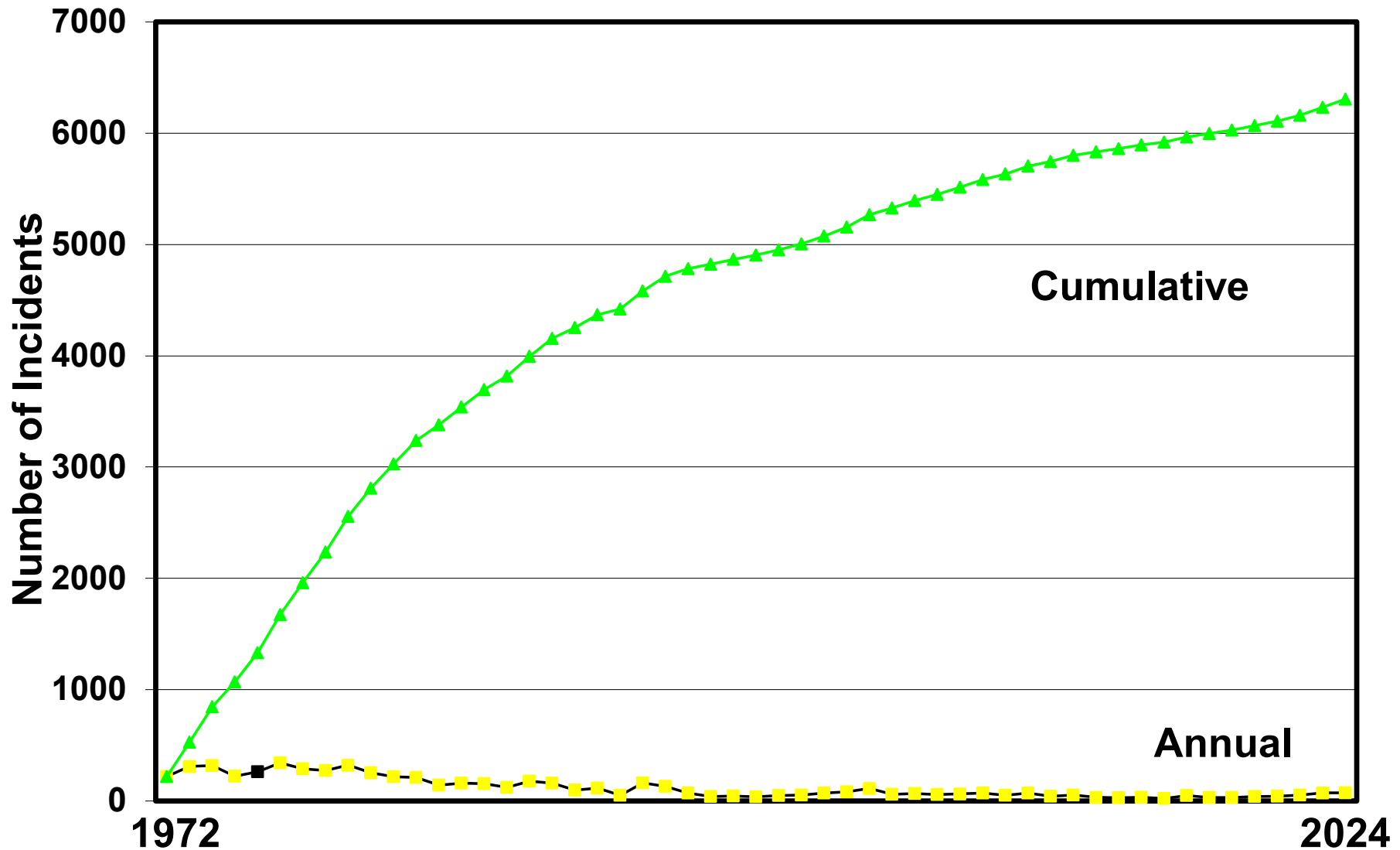
US-Japan
Security Treaty

- **Bilateral agreement that establishes the framework under which U.S. military personnel (and other covered individuals) operate in Japan**
- **The SOFA addresses issues such as:**
 - Use of facilities and areas
 - Criminal/civil jurisdiction
 - Taxes and fees
 - License requirements
 - Customs regulations
- **U.S. – Japan Joint Committee operationalizes the SOFA**
- **The SOFA does not:**
 - Exempt you from obeying Japanese law
 - Give you immunity from Japanese legal system

Drinking and Driving



Don't be
that guy!!



- Drinking and driving is a **serious offense** in Japan, both on base and off base
- Do NOT drink and drive. If you consume even a few sips of alcohol, you will register on the Japanese Kitagawa BAC test = **.03**
- DUI/DWI is subject to 5-years or less imprisonment with forced labor or a fine of up to 1,000,000 yen
- Failure to submit to a Japanese Kitagawa BAC test leads to an immediate arrest, 3 months imprisonment or 500,000 yen fine
- **Many DUIs occur the next morning** when folks think they are fine, but there is still alcohol in their system

Be smart!
Have a plan!
Don't drink and drive!!!



Recent Incidents – Case Studies

Assault

Facts:

- Service member refused to pay an \$8 cab fare
- Tried to run, and punched the driver
- Driver was injured

Consequence: 14 months in Japanese prison

Robbery

Facts:

- SOFA dependent decided to snatch a purse
- Robbed ~\$250 and caused injuries to the victim

Consequence: Convicted in Japanese court and sentenced to 8 years imprisonment

Drugs

Facts:

- SOFA civilian 30,000 tablets of ecstasy mailed to the base
- However, on its way into the country, Japanese Customs inspected the package

Consequence: 7 ½ years in Japanese prison and a \$30,000 fine

Children are not Immune

Facts:

- 15 year-old SOFA dependent heard that another kid was hitting on his girlfriend
- 15 year-old got into a fight outside a restaurant
- Three juveniles sustained injuries

Consequence: Juvenile sentenced to one year in a Japanese juvenile confinement facility

Drinking and Driving

Fact:

- An intoxicated service member drove a car, rear-ended a stopped car, and caused a multi-car collision involving two cars
- Two drivers suffered injuries

Consequence: Convicted in Japanese court and sentenced to 500,000 yen fine.

Unlawful Entry

Facts:

- Service member entered someone else's house in Naha without legitimate reasons
- Arrested by Japanese police

Consequence: Convicted in Japanese court and sentenced to 100,000 yen fine.

Criminal Jurisdiction Under the SOFA

- Japan's *PRIMARY RIGHT*: ALL crimes that violate both Japanese and U.S. law, or
 - Involving non-SOFA status, e.g., local nationals
- Each country has **EXCLUSIVE** jurisdiction over cases that **ONLY** violate the laws of that country.
- US retains jurisdiction over *official duty cases*.





Japanese Criminal Process

BLUF: Try not to think like an American!

- If you are detained
 - May be held *up to 23 days during investigation* before deciding to prosecute
 - **No right to attorney or command representative during questioning**
 - **No right to stop questioning**
- If you are not detained
 - SOFA requires that the US make personnel under investigation/facing trial available for all interviews and proceedings
 - **Cannot leave Japan until Japanese case is finished**



“Gomenasai”

- Can favorably affect outcome in criminal and civil proceedings.
- **COMPLETELY VOLUNTARY!**
- Coordinated through the Foreign Criminal Jurisdiction Office.
- Often leads to Private Settlements.
- **DO NOT ATTEMPT WITHOUT FIRST CONTACTING OSJA, MCIPAC-MCBB.**

DOG OWNERSHIP IN OKINAWA

BLUF: All dog owners are expected to at minimum,

- 1) register their animal with the municipality in which they reside and*
- 2) comply with annual vaccination requirements. Additional requirements may exist depending on the municipality.*

Dog Bites:

- 1) Local Govs – promulgate local ordinances that impose **fin**es/restrictions on dog owners,
- 2) Japanese Police investigate bites and **may take custody** of the dog if they deem warranted (Note: JPs are not beholden to Okinawa Prefectural Government as they are GoJ),
- 3) Japanese Animal Control (DBA) will provide guidance to dog owners and potentially impose restrictions (re: leashing, muzzling, fencing, etc.).

In the event an individual is injured, like in other criminal incidents, victim's (dog owner's) may submit a criminal complaint to JPs which will trigger a **criminal investigation** under the penal code*

 - Jurisdiction shifts to U.S. (NJP, Court-Martial, MEJA)
- Refer to Summary Court
 - Speeding, DUI
 - Fines
- Refer to District Court
 - e.g. murder, drug trafficking, SA, DUI with aggravating factors
 - Observers sent to ensure compliance with the SOFA

Driving Offenses

- **Injury through negligent driving**
 - Typically reported after accident
 - MUST Report Accident, within 72hrs to your insurance company, IN-PERSON.
- **Hit & Run** – Failure to report crash to Police Box
- **Speeding**
 - Typical Speed Limits:
 - 50 kph
 - 80 kph on the expressway (cameras!)
- **DUI = 0.03 BAC**
 - Passengers may also be prosecuted
 - Refusal to take breathalyzer is also a crime

Japanese Compulsory Insurance (JCI)

Covers other party's **bodily injury**.

Property damage coverage not included.

Gets renewed after JCI car inspection
(usually valid for 2 years).

Pays up to approx. **¥1,200,000 (approx. \$12,000)** per person for most cases involving injury

Up to **¥30,000,000 (approx. \$300,000)** per person for a fatal accident and up to **¥40,000,000 (approx. \$400,000)** per person if permanently disabled by the accident.

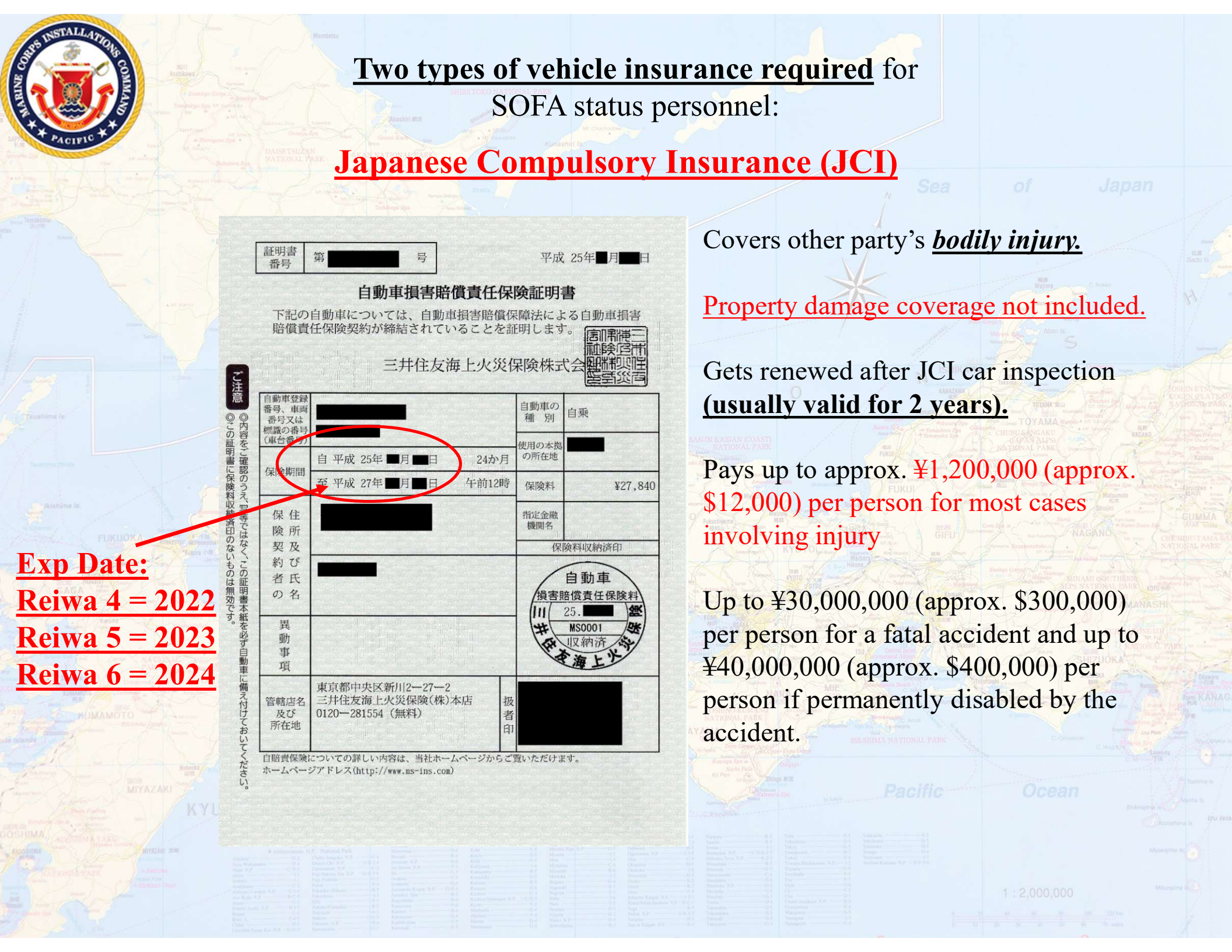

Property Damage Insurance/Liability (PDI/L) “Voluntary Insurance”

“3 or 6 months to **1 year coverage**, requires annual renewal.

Covers other party’s *property damage*.

Covers other party’s **bodily injury** exceeding the amount of JCI coverage.

SOFA License drivers are required to have PDI coverage of **no less than ¥3,000,000** (approx. \$30,000) for property damage and **¥30,000,000** (approx. \$300,000) for bodily injury.

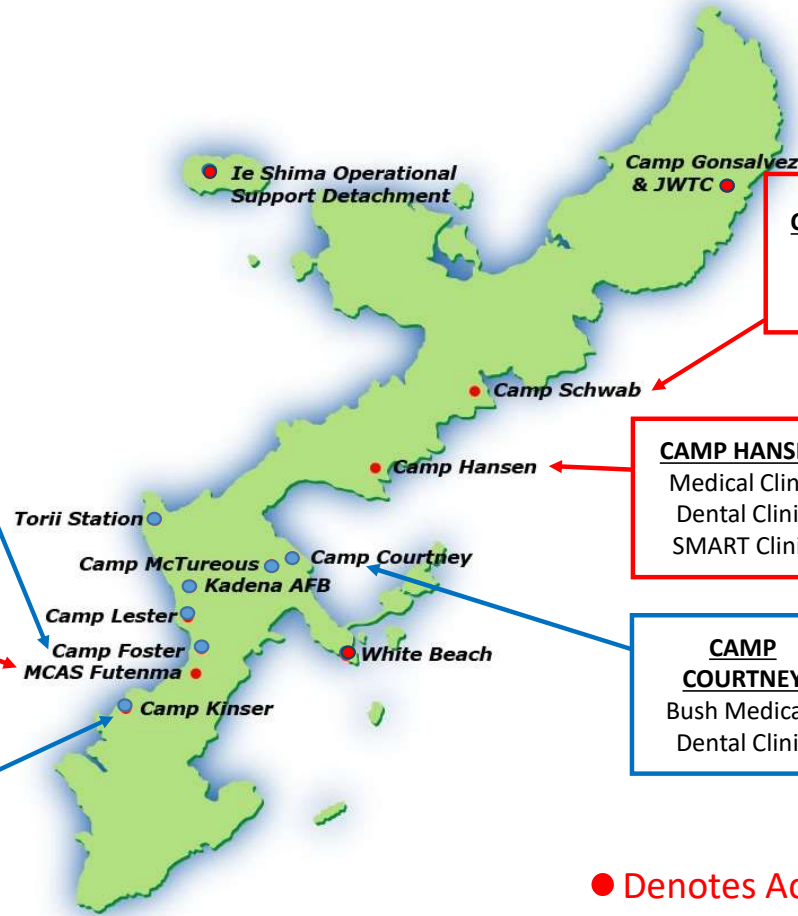

TRICARE Prime Overseas

- TRICARE Prime Overseas is available to Active Duty Service Members (ADSMs) and their eligible, command-sponsored family members who live with them near a military hospital or clinic.
 - **Enrollment:** Enrollment is required.
 - **Costs:** No enrollment fees, but family members will pay cost-shares for prescriptions filled at overseas pharmacies.
 - **Getting care:** Get care from an assigned primary care manager at a military hospital or clinic in most cases. Referrals and/or pre-authorizations are required for specialty care.
- **What You Should Know**
 - No Enrollment Fees
 - No out-of-pocket costs when you get covered healthcare services from your PCM. **However**, you may have out of pocket costs if you see a nonparticipating non-network provider, even with a pre-authorization.
 - When seeing a non-participating non-network provider, expect to pay the full cost of care up front and file a claim to get money back. You are responsible for paying any amount that exceeds the TRICARE allowable charge.



TRICARE Prime Enrollment

- Complete the *TRICARE Prime Enrollment* (DD Form 2876) in person at the TRICARE office at Camp Foster Naval Hospital.
- **Must have the following:**
 - Paper copy of orders
 - Command sponsorship documents (Area clearance or Dependent Entry Approval-DEA)

You may call your current regional contractor to transfer TRICARE Prime enrollment: 1-877-678-1208

TRICARE Select Overseas

- TRICARE Select Overseas is available to command-sponsored and non-command-sponsored Active Duty Family Members (ADFMs), retired service members and their family members, survivors, and others living or traveling overseas.
 - Enrollment: Enrollment is required.
 - Costs: No enrollment fee for ADFMs. Retirees, their families, and others pay enrollment fees.
 - Getting care: Seek care from any purchased care sector provider.*
 - ✓ Referrals aren't required for most healthcare services.
 - ✓ Pre-authorization is required for certain services.
 - ✓ Overseas providers aren't required to bill TRICARE for you.
 - ✓ Beneficiaries should expect to pay up front and file claims for reimbursement.

Note: ADSMs aren't eligible for TRICARE Select Overseas. Those enrolled in TRICARE Select Overseas in the Philippines and Panama are reimbursed based on government-provided foreign fee schedules.

* In the Philippines, you're encouraged to seek care from Philippine Preferred Provider Network providers



TRICARE Plus Program



- TRICARE Plus is a primary care program offered at some military hospitals and clinics.
 - **Enrollment:** Enrollment is required. Enrollment is only for the military hospital or clinic where you enrolled.
 - **Getting Care:** TRICARE Plus gives you access to get primary care at your military hospital or clinic. You pay nothing out-of-pocket. However, there is a subsistence charge for inpatient care obtained in a military hospital or clinic.
 - TRICARE Plus doesn't guarantee access to specialty care at the military hospital or clinic where you're enrolled.



TRICARE Young Adult

- TRICARE Young Adult is available to qualified unmarried dependents of TRICARE-eligible sponsors who are:
 - At least age 21, but not yet age 26
 - Not eligible to enroll in an employer-sponsored health plan
 - Not otherwise eligible for TRICARE coverage
 - Not a uniformed service sponsor (for example, a member of the Selected Reserve)
- For TYA qualification, cost, and enrollment information, visit www.tricare.mil/tya



Non-TRICARE Patients

- Steps to seeking space-available care at USNH Okinawa:
 - 1. Sponsor Documentation**
 - Have a copy of sponsor's **Letter of Employment/Authorization**

- **Good to Know:**
 - Emergency Room is open 24/7 for all patients
 - Pharmacy access is available to all eligible beneficiaries
- **Need a Civilian Provider in Japan?**
 - TRICARE Beneficiaries: Use the International SOS Overseas Provider Directory
 - Non-TRICARE Individuals: Contact your private insurance provider
 - Coordinate care through your medical insurance provider
 - The MTF may offer space-available care but is not guaranteed

Family/friends visiting? Travel Insurance is strongly recommended --- off-base care can be costly.

Referral Process

Referral - When your Primary Care Manager (PCM) recommends you see a specialist to get the right care for a specific health concern.

- If you require a referral for a specialty, you must see your PCM first
 - PCM will determine if specialty care is needed and will submit a referral
 - **TRICARE Prime:** Confirm enrollment status. Referrals are reviewed by International SOS for pre-authorization
 - **Non-TRICARE Prime:** Referral Management office at USNHO will assist with processing of referral
 - If approved, care may be coordinated at USNH Okinawa, Host Nation Facility, or Off-island

Help us Help You: Best Practices for a Smooth Referral Experience

To avoid delays and ensure you get the right care quickly; we recommend the following:

- Contact the Referral Management Office within 72hrs after a referral has been placed by your PCM
 - Referral Management Office @ 646-7332 (DSN) or 098-971-7332 (when calling from a cellphone)
- Keep your contact information up to date
 - Ensure your phone number, email, and address are current in DEERS and at the MTF
- Check your messages regularly
 - You may be contacted by the Referral Office, International SOS, or the Host Nation facility
- Follow up if you haven't heard back

How to Check into Dental

- **Command Sponsored Family Member**

- Check into the dental clinic that primarily supports the sponsor or the dental clinic closest to where you live.
 - Bring a copy of your sponsor's orders.
 - Bring a copy of Dependent Entry Approval (DEA), area clearance, or command sponsorship memo.
 - If you already have a military dental record, please bring it.
 - If you have civilian dental records or radiographs, please bring to merge with your new military dental record.

What is SHIMI (SEIMEISAI)?



One of the largest annual events in Okinawa to visit the family tomb to commemorate their ancestors.

When does it take place?

It takes place in April time frame.



What do people do?



Clean up the family tomb and the surrounding areas, light incense and give prayers to the ancestors. Then family members gather together and eat the feast in front of the tomb.

Obon



What is Obon?



According to the Buddhist belief, it is the time of the year that the spirits of dead return home to visit.

When is it observed in Okinawa?

It is observed Jul 13-15
(some regions until 16) of
lunar calendar. The dates
change every year.



What do people do?

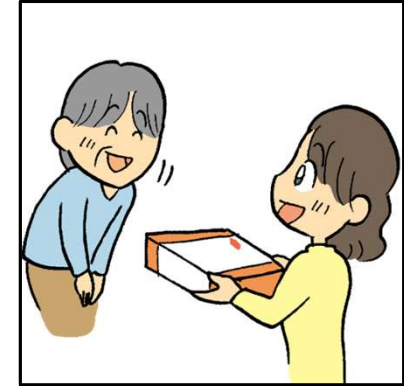
1st day (UNKEI)



It is the day that the spirits of ancestors come back home to visit. People clean up the family altar and make an offering of flowers and food to the altar. Light incense/lanterns on the evening to guide the spirits of ancestors home.

What do people do?

2nd day (NAKABI)



Between the 1st-3rd day, people visit other relatives home to greet relatives and spirits of ancestors and offer summer gifts called *ochugen* to the ancestral spirits.

What do people do?

3rd day (UKUI)



3rd day (UKUI): Highlight of the Obon: It is the day to send-off the spirits of ancestors to the other world. All the family members enjoy a feast together in the evening. When the time comes to say good-bye to the ancestral spirits, all present light incense and give prayers to the ancestral spirits.

What is Eisa dance?



During the Obon, Eisa dance is performed in Okinawa to console the ancestral spirits. It is performed on the last day of the three-day Obon celebration to bid farewell to the ancestral spirits (michi-junee).

Okinawan superstition



“Do not swim in the ocean during Obon as the spirits of people who did not die in peace will pull your legs to take you to the other world with them.”

Fact:



During the Obon season in Okinawa, typhoons approach the sea of Japan and the high waves occurs. Many people get washed away by the high waves so in order to avoid the incidents, it is believed that the superstition was passed down.

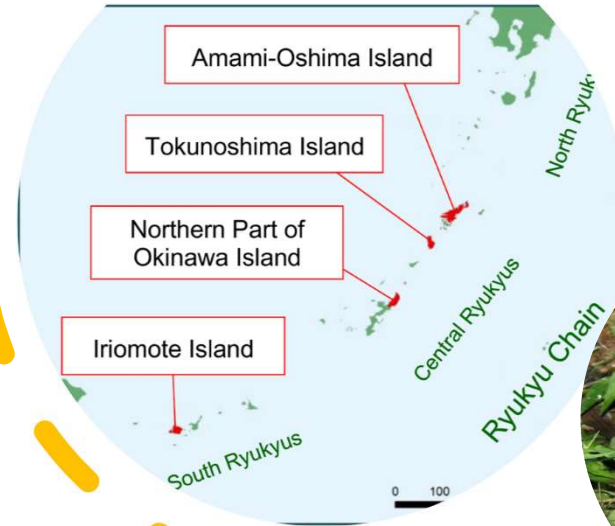

- ❖ **Burned down the fifth time on 31 Oct 2019.
(1453, 1660, 1709, 1945)**
- ❖ **7 castle buildings occupying some 4800 square meters
in total were gutted.**
- ❖ **421 cultural assets from the Ryukyu Kingdom era were
burned down.**
- ❖ **Reconstruction is scheduled to be completed in 2026.**
- ❖ **Estimated reconstruction cost: Over 15 billion yen.
(142 million dollars)**

Japan's 5th Natural World Heritage Site

- In July 2021, Yanbaru in northern Okinawa, Iriomote Island, Amami Oshima, and Tokunoshima were designated a UNESCO Natural Heritage Site for their vital biodiversity.
- The Okinawa Rail (the northern part of Okinawa) and Iriomote cat (Iriomote Island) are nationally protected animal species that inhabit the islands.

The Japanese gesture of "Who, me?" is pointing at your nose, not your chest.



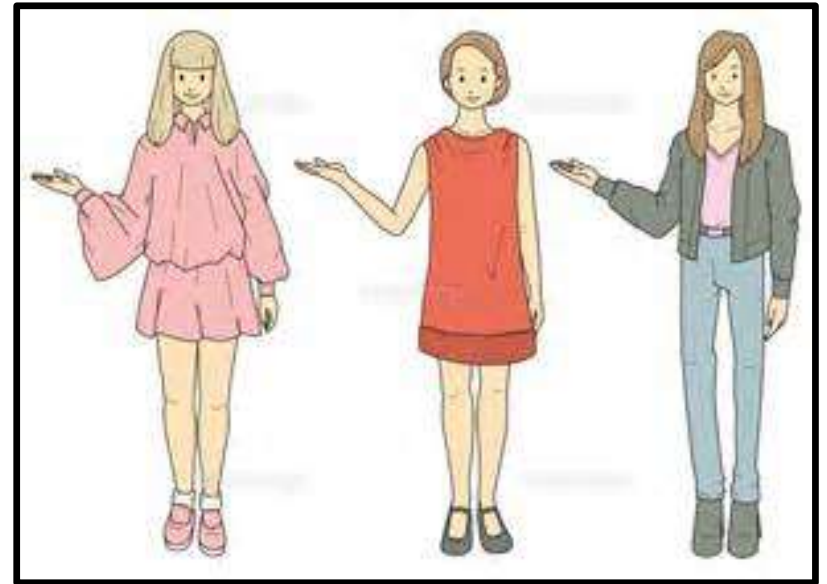

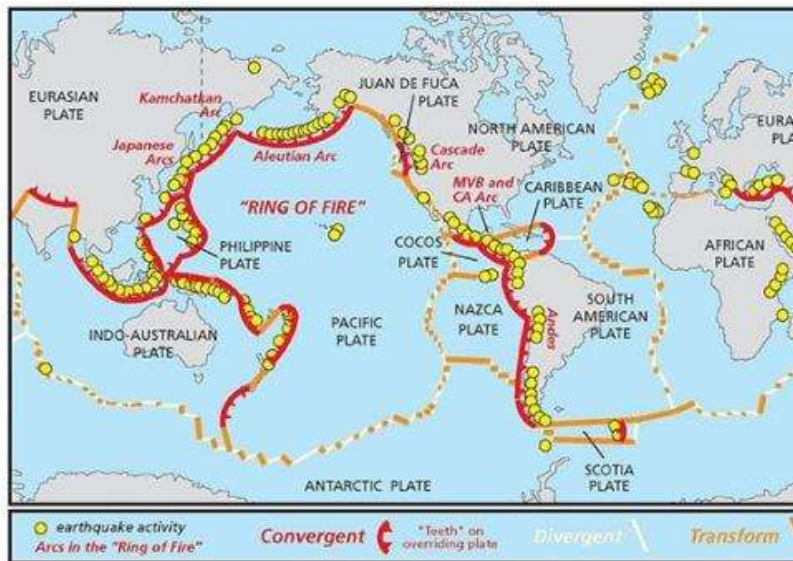

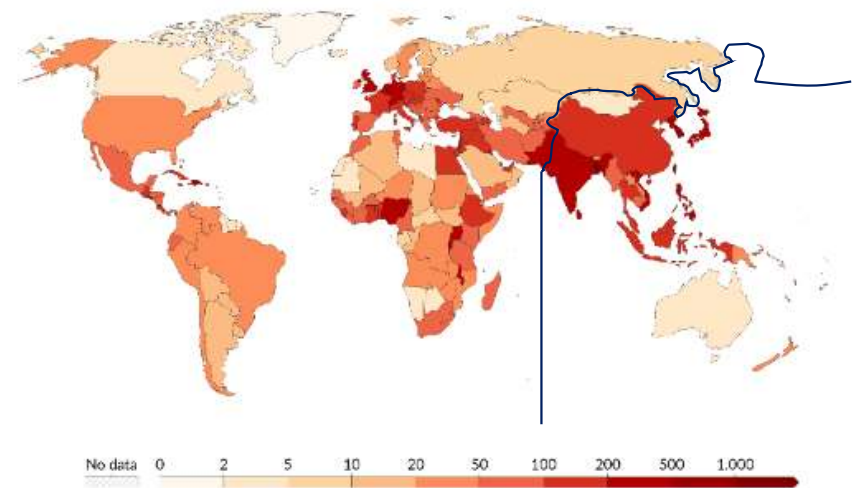

- Collect important contacts information, including contact information for locations your family frequents.
- Map out and practice evacuation routes from each room in your home.
- Establish a family communications plan and rally point.

- Identify where the utility shut-off location is in your home and how to use it.
- Write down safety considerations/skills and practice with your family.

Emergency Kit Check-List

(Maintain a minimum of 3 days of supplies, recommend up to 14 days)

- Water (one gallon of water a day per person/pet).
- Non-perishable foods for family and pets, don't forget a can opener.
- Infant formula and diapers.
- Battery powered radio and a NOAA Weather Radio with tone alerts.
- Flashlight/lanterns/chargers/portable power bank/extra batteries.
- First aid kit and dust masks.
- Hand wipes, garbage bags and plastic ties for personal sanitation, in case of water outage.
- Feminine supplies and personal hygiene items.
- Sleeping bag or warm blanket for each person.
- A change of clothing: long sleeved shirt, long pants, and sturdy shoes.
- Prescription medications and glasses.
- Household chlorine bleach and medicine dropper. (Bleach can be used as a disinfectant when diluted nine parts water to one part bleach. In an emergency, you can use it to treat water by using 16 drops of regular household liquid bleach per gallon of water. Do not use scented, color safe, or bleaches with added cleaners.)
- Cash or traveler's checks and change (Yen & Dollars).
- Important documents such as insurance policies, identification, passports, and bank account records in a waterproof/portable container.
- Emergency reference material such as a first aid book or information from ready.gov.
- Entertainment during power outages, like books, games, puzzles, paper and pencil, or other activities for children.

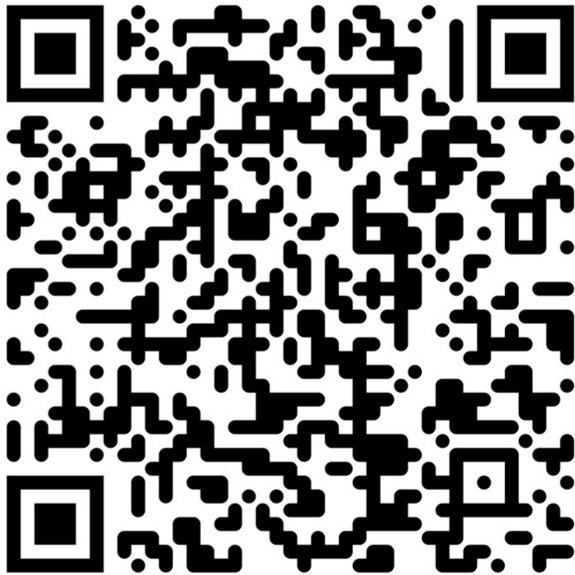
